QUALIFIED TRANSIT AND PARKING PLANS

Commuter benefits allow you to use tax-free payroll contributions for eligible commuting costs, such as public transit fares, vanpooling, and parking fees.

How It Works

Contribute pre-tax money from each paycheck within IRS limits. Your election should equal your planned eligible parking or transit expenses for the plan year. Employer policies may vary, but in general, you can enroll, make changes, or end your participation on a monthly basis; unused funds may be carried over month-to-month and year-to-year as long as you remain eligible. Funds cannot be transferred between parking and transit accounts. Reimbursements may not exceed the IRS monthly limit or available funds in your account.

Pay For Expenses



Use your Alerus Health Benefits Visa® debit card to pay providers directly from your benefits account, or reimburse yourself by submitting a claim for eligible expenses you've already paid. Claims must be submitted within


the time frame provided in your plan details.

Eligible Expenses

A plan participant (not family members or dependents) may use funds to pay for their eligible transit or parking expenses.

- Qualified transit plans: public transportation costs (bus, train, subway, ferry) and eligible vanpooling services used for commuting to and from work. Personal vehicle commuting costs are not eligible.
- Qualified parking plans: parking costs at or near your
 workplace or at a location from which you commute using
 mass transit or vanpooling. Parking costs at or near your home,
 or parking that is not related to your commute to work are not
 eligible.

Manage Your Account





- Check your account balance and see your spending history
- Order additional debit cards
- Sign up for direct deposit or text/SMS alerts
- Submit claims for reimbursement
- Add digital card to mobile wallet for convenient use
